EXTENSION OF THE LONG STOP DATE FOR COMPLETION OF THE PROPOSED ACQUISITION OF SHARES IN HORIZON GREENTECH RESOURCES SDN BHD

1. INTRODUCTION

The board of directors (the “**Board**”) of Annica Holdings Limited (the “**Company**”), refers to its announcements dated 23 December 2016, 22 March 2017, 31 August 2017, 25 September 2017 and 30 October 2017 (“**30 October Announcement**”) (together, the “**Earlier Announcements**”) in relation to the Company’s entry into a conditional sale and purchase agreement (the “**Agreement**”) on the proposed acquisition (the “**Proposed Acquisition**”) of 49.0% of the issued and paid-up share capital of Horizon Greentech Resources Sdn. Bhd. (the “**Target**”).

Unless otherwise defined, all capitalised terms used herein shall bear the same meaning ascribed to them in the Earlier Announcements.

2. EXTENSION OF LONG STOP DATE

As announced in the 30 October Announcement, the Parties have mutually agreed to extend the Long Stop Date for Completion of the Proposed Acquisition from 31 October 2017 to 23 December 2017 to finalise the formalities for the transfer of the Sale Shares.

The Company wishes to announce that as the Vendors will require more time to obtain certain regulatory licences relating to the Target with the relevant authorities, the Parties have mutually agreed to further extend the Long Stop Date for Completion of the Proposed Acquisition for a further three (3) months i.e. from 23 December 2017 to 23 March 2018.

Save for the aforesaid extension of the Long Stop Date, all the other terms in the Agreement remain fully valid and in force.

3. CAUTIONARY STATEMENT

The Company will make the necessary follow-up announcements upon Completion and/ or if there any material developments relating to the Proposed Acquisition. Shareholders and potential investors are advised to read this announcement and any further announcements by the Company carefully.
