The New Shares are expected to be listed and quoted on Catalist of the Singapore Exchange Securities Trading Limited with effect from 9.00 a.m., Tuesday, 23 May 2017.

Following the allotment and issuance of the New Shares pursuant to Warrants exercise, the total number of issued shares of the Company has increased from 7,049,522,333 to 7,084,778,333.

The Company has further raised proceeds of S\$246,792 from the exercise of 35,256,000 Warrants. As at the date of this announcement, the total proceeds from the exercise of Warrants is S\$4,837,340.82 ("**Exercise Proceeds**"). The Company will make periodic announcements on the utilisation of the Exercise Proceeds as and when such proceeds are materially disbursed.
