The Board considers Mr Wee to be independent for the purpose of Rule 704(7) of the Catalist Rules of the SGX-ST;
- 2) Mr Hau Khee Wee (“**Mr Hau**”), who was re-elected as a Director of the Company, remains as the Chairman of the Nominating and Remuneration Committees respectively, and a member of the Audit Committee. The Board considers Mr Hau to be independent for the purpose of Rule 704(7) of the Catalist Rules of the SGX-ST; and
- 3) Dr Oh Beng Teck (“**Dr Oh**”), who was re-elected as a Director of the Company, remains a member of the Audit, Nominating and Remuneration Committees respectively. The Board considers Dr Oh to be independent for the purpose of Rule 704(7) of the Catalist Rules of the SGX-ST.
