SPACKMAN ENTERTAINMENT GROUP'S *MASTER* PRESOLD TO MORE THAN 30 COUNTRIES

- *MASTER, a Korean crime-action film, has been sold to 31 countries including the US, Hong Kong, Taiwan and Singapore*
- *The film stars three of Korea's top actors – Lee Byung-hun, Gang Dong-won and Kim Woo-bin and will be released in Korea on 21st December 2016*

Singapore, 6 December 2016 – Spackman Entertainment Group Limited (“**Spackman Entertainment Group**” or the “**Company**” and together with its subsidiaries, the “**Group**”), announced today that its crime-action film, *MASTER*, produced by its indirect wholly-owned subsidiary Zip Cinema Co., Ltd. (“**ZIP Cinema**”), has been sold to 31 countries prior to its first release in Korea. The film is expected to be released in Korea on 21st December 2016.

The distribution rights of *MASTER* have been sold to the United States, Canada, Australia, New Zealand, Italy, Taiwan, Hong Kong, Singapore, Thailand and Philippines amongst other countries. The foreign release of *MASTER* will be launched first in the United States in December, followed by Hong Kong, Taiwan and Singapore.

MASTER is slated to be screened in Singapore theatres around 12 January 2017.

The crime-action film is directed by Cho Ui-seok, who helmed the film *COLD EYES (2013)*, another zip Cinema production. *COLD EYES (2013)* was one of the top 10 films at the Korean box office in 2013, grossing a total of 5.5 million tickets.

MASTER features three of Korea's top actors: Lee Byung-hun, Gang Dong-won and Kim Woo-bin. The film depicts the continuous chase of swindlers who committed a massive fraud of hundreds of billion dollars.

Our films are theatrically distributed and released in Korea and overseas markets, as well as for subsequent post-theatrical worldwide release in other forms of media, including cable TV, broadcast TV, IPTV, video-on-demand, and home video/DVD, etc. We release all of our motion pictures into wide-theatrical exhibition initially in Korea, and then in overseas and ancillary markets.

We also operate a café-lounge called Upper West, in the Gangnam district of Seoul and own a professional photography studio, noon pictures Co., Ltd..

The Group is a strategic shareholder of Spackman Media Group Limited ("**SMGL**"). SMGL, a company incorporated in Hong Kong, together with its subsidiaries, collectively is the leading talent agency and entertainment content production company in Korea, managing over 50 artistes including some of the top names in the Korean entertainment industry. SMGL operates the talent management business through renowned agencies such as MS Team Entertainment Co., Ltd., Fiftyone K Inc., SBD Entertainment Inc., UL Entertainment Co., Ltd., and Kook Entertainment Co., Ltd.

On 30 December 2015, the Group announced a share swap agreement for the sale of its equity interest in its associated company, SMGPL, in consideration for 7,500,000 ordinary shares in the capital of Spackman Media Group Limited. On 16 May 2016, the Group announced the completion of the share swap.

On 14 September 2016, the Group announced the completion of its disposal of the Company's entire equity interest in its indirect wholly-owned subsidiary, Opus Pictures Limited Liability Company.
